We cannot thank you all enough for the love, empathy, and compassion you bestowed on us.

In the relatively quiet reflective time in the last several weeks, we had an opportunity to go over the donation details. We found that a little over one-third of your financial contributions was ultimately needed to cover Ujwal's medical expenses. We then decided to give away, as Ujwal would have liked, the surplus funds to support more fellow Nepalis who are struggling with Covid-related medical and livelihood difficulties.

After a discussion of their due diligence work and interview notes, we then selected seven organizations that we felt were doing much needed community service work in these pandemic times.

We fondly cherish all the happy and inspiring memories that Ujwal has left behind for us. As you all know, he had a vision for an equitable and just Nepal in which all Nepalis could live up to their full potential. To keep that vision alive and growing, we will soon be setting up a foundation in Ujwal's name to continue the work that he had started. The Grantee Organizations

First, a few words on the selection process.

By the second week of June, 2021, it was clear that there was going to be surplus funds. Ujwal Thapa's family's first instinct was to return the surplus funds to the donors. But with about 2,800 individual donors from around the world who had donated money via different online platforms, returning the money to each and every one of them, after accounting for the expenses and online platform fees, turned out to be a logistical impossibility.

And so, in the third week of June, 2021, the family asked some of his friends and associates to help select worthy organizations that could be funded with the surplus money.

The friends formed a working group, and started with a list of 41 entities. They gave considerations to well-established and well-run organizations that had been responsive to Covid-related medical and livelihood challenges of the most vulnerable people in their communities. They conducted online interviews with the organizations to assess for relevance, impact, sustainability, team strength, and geographical, gender and ethnic diversity. After further discussions with the family members, they then selected seven organizations, and helped decide on the allocation of the surplus funds. Finally, they assigned a liaison person to each of the grantee organization. These liaison people will monitor the use of the funds, and publicly report back, in three to six months' time, about the outputs and outcomes created by the grants.

Bhore Nepal is a campaign-focused non-profit organization working, among others, for the upliftment of Musahar community members, who are among the most vulnerable communities in the Terai. In 2020, Bhore ran Covid-relief



activities to provide food packages and medical services to the poor, especially to pregnant women. Bhore was formally registered with District Administration Office in Dhanusha. It was affiliated with Social Welfare Council (SWC) in 2009. It has a national office in Kathmandu in Tilganga, provincial office in Janakpurdham, Province 2, and local level office in Chandrangar Rural Municipality in Sarlahi, Province 2.

Bhore intends to make use of the Ujwal Thapa Memorial Grant to distribute food and medical packages to pregnant and post-natal women in Sarlahi district.



In recent years, it has made a name for itself by being among the first NGOs that speedily responds with relief materials in times of disasters. In June 2021, it was quick to provide food and medicines to the victims in the flood-devastated Melamchi area. In 2020-21, Heartbeat distributed meals to daily wage-laborers who had lost all means of livelihood support. It also turned many such women into small-scale entrepreneurs, by creating a group called Women-on-Wheels, a community of female traders who sell vegetables, fruits, clothes, and the like by the roadside on their *thela*.

Heartbeat intends to make use of the Ujwal Thapa Memorial Grant as a top-up resource to provide food relief to 40 women-on-wheels community members in the Lalitpur area. These women, who are often the sole breadwinners of their families, have lost their income in these pandemic times.

Madhesh Human Rights Home (Mahuri Home) was founded in 2008 with the commitment to empower the underprivileged, the socially excluded and the oppressed, including the indigenous and minority populations in and around Kapilvastu district. This organization is an outcome of collective and collaborative initiation of a dynamic team comprising of experts in the areas of human rights, media, Dalit and women empowerment, non-violent conflict transformation and peace education, and was founded in the aftermath of violent riots in Kapilvastu due to assassination of Mohid Khan in 2007.

In 2020-21, it reoriented its work to reduce the adverse social effects of Covid: disposing of the dead bodies, sending the sick to the ICUs of local hospitals, procuring oxygen cylinders, and distributing clothes and stationery to children who could not go to school.

Mahuri Home intends to make use of the Ujwal Thapa Memorial Grant as top-up resource to serve the Natuwas -- a hitherto neglected nomadic tribe in Kapilvastu. Working with the local palika for additional funds, it will provide necessary clothes and stationery to about 200 Natuwa families.

Nepal Critical Care Development Foundation (NCCDF) was established in 2012 as a not-for-profit organisation. Though it is based in Kathmandu, it works all over the country. Its objective is to develop critical care medical service in Nepal, and help upgrade ICU services in the country. To that end, it offers continuing medical education and training programs such as Infection Prevention and Control, CPR for Nurses, Tracheostomy Care, and the like to nurses so that their skills are upgraded to take better care of critically ill patients. In 2020-21, NCCDF distributed 72 oxygen concentrators to public hospitals, provided PPEs and masks, and trained nurses and doctors on advanced critical care methods.

NCCDF intends to make use of the Ujwal Thapa Memorial Grant to provide scholarships to needy nurses at government-run hospitals in Sudurpaschim Pradesh to attend two-day training on professional skills upgrade courses such as ICU management, ventilator usage, respiratory care, and communications with patients.

National Innovation Centre (NIC) was established in 2012 as a not-for-profit organization. Led by Magsaysay Award winner, Dr. Mahabir Pun, its offices are in Kirtipur. NIC's mission is to help stop brain drain by providing an array of support services to Nepali innovators and entrepreneurs. At present, NIC runs projects in fields such as health care, urban transport, artificial intelligence, IT and



agriculture. In 2020, NIC responded to the Covid crisis by making and distributing PPEs and safety gear to front-line health workers, repairing ventilators, and constructing and installing mini-oxygen plants in rural hospitals.

NIC intends to make use of the Ujwal Thapa Memorial Grant to make and install three mini-oxygen plants in rural hospitals, with a focus on Pradesh 1 and Gandaki Pradesh. Since each plant costs around 19 lakh, NIC will work in collaboration with respective hospitals and municipalities, and may use some of its own funds to cover the shortfall. Named after the village of Oda in Kalikot, Oda Foundation was set up as a government-registered NGO in 2013 in Karnali Province. It has a 501(c) 3 arm in the US, which publicizes its community development work, and raises funds from the Nepali diaspora and beyond. It has long been involved in the field of healthcare, education and community mobilization. In 2020 and 2021, in response to Covid in Kalikot, where many are cross-border migrant workers, it worked closely with the local government to set up and run an isolation center, conducted preventive activities and provided food for work opportunities.

With additional support from the local government, Oda Foundation intends to make use of the Ujwal Thapa Memorial Grant to build a two-room in-patient center, from where medical advice and health services will be dispensed to the needy.

Sano Paila was established in 2006. It has a track record of successfully managing community issues often ignored by the government, private sector, and other NGOs. Its areas of work span from youth empowerment, drug rehabilitation, health improvement and advocacy, peacebuilding, crime prevention and reformation, anti- trafficking and child protection, access to education, livelihood enhancement to crisis response.

For crisis response, in the first and the second Covid wave, Sano Paila played an important role by responding in a multi-pronged manner to best serve the needs of the most vulnerable by serving hot meals daily to day-laborers, Dalit and other disadvantaged community members in Province-2 and Sudur Paschim Province. It also distributed meals to returnee migrants at the borders in Parsa and Mahottari; provided nutritional meals to Covid patients in Parsa and Dhanusha districts; initiated an integrated help-desk to provide emergency supplies during the lockdown; ran three isolation centers; and, provided PPEs, testing booths and ventilators to the government hospitals in Province-2. It also started a free telemedicine service for Covid patients.

Sano Paila intends to make use of the Ujwal Thapa Memorial Grant to cover the scale-up expenses of the telemedicine service for six months. This scale-up will serve people across Nepal by employing doctors and paramedical professionals who provide up-to-date healthcare information in these pandemic times.



4. Leverage:

The Organization may use this Grant to leverage additional funds from its own sources and/or from other funding entities to scale up the impact of the work undertaken under this MoU.

5. Obligations of the Organization:

- a. The Organization shall be transparent as to the use of the Grant and cooperate with the Liaison Officer by providing the necessary details and documents mentioned in Clause 3 of this MoU.
- b. The Organization shall not use this Grant for personal advertisement or personal
- c. The Organization shall not delegate the Grant utilization or transfer funds to another organization.
- d. If the Organization is unable to utilize the Grant or if the Grantor finds that Organization is unable to utilize the Grant for whatsoever reasons then the Organization shall return the Grant to the Grantor. However, if the Grant or part thereof is already utilized then the Organization shall submit a separate report as per Clause 3 (a) to the extent of utilize Grant.

6. Rights of the Grantor:

- a. The Grantor shall have the right to ask for information regarding the details mentioned in Clause 3 this Agreement.
- b. The Grantor shall have the right to demand the return of the Grant Amount if she deems that the Grantee has not been complying with the terms of this Agreement.

7. Other:

- a. Entire Agreement: This Agreement constitutes the entire and complete agreement between the Parties hereto and supersedes any prior oral or written agreements between the parties. It is expressly agreed that there are no verbal understanding or agreements which in any way change the terms, covenants and conditions herein set forth, and that no modification of this Agreement and no waiver of any of its terms and conditions shall be effective unless made in writing and duly executed by the Parties hereto.
- b. Binding Effect: This Agreement and all covenants, terms and provisions contained herein shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.
- c. Counterparts: This Agreement may be executed in one or more counterparts which together shall constitute one and the same Agreement and shall be binding on the Parties.



- d. Assignment or Subcontracting: Either Party shall not transfer, assign or sub-contract its rights or obligations under this Agreement to third parties without written consent of the other Party.
- e. Amendment: This Agreement constitutes a legally binding obligation between both parties hereto. No changes, alteration or modifications hereto shall be effective unless it is in writing, refers to this Agreement and is duly executed by each party to this Agreement.
- f. Cooperation: The Parties shall cooperate with each other and provide assistance required for carrying out the Services under the Agreement.
- g. Notice: Any notice to either party shall be in telex, or electronic mail or any other medium as determined by the Grantor:
